The Policy Committee (PC) on Transportation met in the Multi-Purpose Room of the Historic Courthouse on February 13, 2020 at 100 Main Street in Hinesville at 9:00 AM.

1. Call to Order

3. Approval of Minutes

4. Old Business

- a) GDOT:
 - a. Design Stage:

- US 84 Freight Connector the R.O.W. has been pushed back to next year. They will begin to acquire R.O.W. within the next year and a half. Preliminary design and environmental work are ongoing. Supplemental preliminary plan review is scheduled for next month, on schedule to submit a draft environmental report this month.
- Flemington Curve Improvements let 2020-Final design is ongoing. Appraisals are being prepared for R.O.W. negotiation.
- Taylors Creek Bridge let January 2020- R.O.W. acquisition is ongoing, and they are wrapping up final design. Dealing with fiber cable on base.

b. Under Construction:

- I-95 Resurfacing should be complete by the end of November, a lot of the asphalt they have installed has failed already, they are redoing it.
- 38 Connector resurfacing. Pre-con has been held and contractor should start in middle of April.
- Resurfacing on US 84 from O.C. Martin Drive to I-95 on schedule to let in March.
 - Joey Brown stated that the construction schedule for the bypass is 2024.

b) LOCAL:

a. Under Construction:

- S. Main Sidewalk all sidewalks have been installed from Glenn Bryant Road to Airport Road. In process of finishing Ralph Quarterman Drive. The T-SPLOST referendum will be held on March 24.
- c) Liberty Transit:
 - Ridership has been increasing. 24-month average .80%, 12-month average 2.52%.
- d) Transportation Comment Log:
 - a. There was a previous complaint about lack of a pedestrian crosswalk across US 17 between the Midway Museum and the Historic Cemetery. Byron stated that GDOT is aware of this.
 - b. County Commissioner Stevens asked that GDOT consider placing a "no turn on red' sign at the intersection of 196E and Hwy 84.

c) Legislative Update:

d) Performance Measures:

a) Jeff handed out maps to the committee members demonstrating residential development in Liberty County and including Long County.

5. New Business

a) 2020-2045 MTP Project Status Update:

Rachel Hatcher with RS&H gave this presentation containing the unconstrained project list. Rachel explained how this list came about and after adopting this list, where we go from here. There was discussion of moving and extending Wallace Martin Road to assist in traffic flow.

Clemontine Washington made a motion to approve the 2045 unconstrained project list, seconded by Gary Gilliard and all voted in favor.

- b) Elect Chair and Vice-Chair for 2020: A nominating committee consisting of Paul Hawkins, Allen Brown and Lily Baker have suggested Donald Lovette as chairman and Clemontine Washington as vice-chair.
 - Gary Gilliard made a motion to approve, seconded by Allen Brown and all voted in favor.






Residential development in Hinesville, Flemington, Allenhurst, Walthourville, Fort Stewart & Long County area juxtaposed against the 2040 MTP.


