HAMPO PC MINUTES: June 10, 2021

The Policy Committee (PC) on Transportation met in Room 2100 of the Historic Court House via phone/ZOOM at 100 N. Main Street in Hinesville at 9:00 AM on June 10, 2021.

1) CALL TO ORDER:

• Chairman Lovette called the meeting to order.

2) APPROVAL OF MINUTES:

• Allen Brown made a motion to approve the minutes from the April 8, 2021, meeting, seconded by Clemontine Washington and all voted in favor.

3) STATUS UPDATES

a. Project Status Update: Katie Proctor with GDOT

SR 38 Connector from SR/US 84 to SR 119 environmental activities and preliminary plans are 100% complete. ROW has been authorized

SR 119 at Taylors Creek-Bridge replacement plans are 100% complete. It is awaiting environmental approvals from the Corp of Engineers. Anticipated to start construction in September 2021.

CR 171/Lewis Frasier Rd @ Peacock Creek bridge replacement project is still in first stages of development. Concept development is still in progress and initial environmental survey is underway.

Active Projects: SR 38/US 84 at CR 73/Old Sunbury Road is under construction. It was LET in February. Notice to proceed was issued in May and the completion date is anticipated in November of 2022.

b. Transportation Update: Rachel Hatcher

Rachel stated that the Covid-19 sanitization and protections remain in effect. Three new buses were delivered on March 31, 2021, the third of which is being cleared for service by the end of the week. Construction underway on the ADA infrastructure improvement projects, including at Savannah Tech on Technology Drive and on General Stewart Way. New Liberty Transit vehicles are sized more appropriately to the system ridership and allows for drivers without CDL licenses to drive the buses. Year over year paratransit ridership was up in April, but down from March ridership. System ridership was up in April for fixed route service. Route 1 and 2 increased ridership, with Route 3 slightly decreasing ridership in April. Rachel presented several slides containing the ongoing installation of sidewalks and shelters.

c. **Transportation Public Comment Log:** Ongoing: CAC member Phil Odom submitted a list of operational and maintenance issues that have been forwarded to GDOT and Local Jurisdictions for remediation.

New Comments: Resident on Charlotte Court off Veterans Parkway in Hinesville made a complaint that the resultant median after Veterans Parkway widening causes drivers to have to make a U-turn at Grove Point Drive. Crash data was pulled using GDOT Numetric Data and AADT sourced from TADA. HAMPO staff coordinated with City of Hinesville and GDOT District 5 and provided agencies with a copy of the screening and a summary of findings. 25 total crashes occurred at this intersection between 2013-2019, with no injuries or fatalities from those crashes. Most of those crashes were rear end collisions and animal strike/not a collision with motor vehicle.

Phil noted that the planned infrastructure improvements on US 84 will be like the Veterans Parkway widening and will cause the same issue along that corridor as well.

Rachel stated that this improves safety for the public, and even with the few rear end collisions occurring, some collisions are to be expected.

d. **GDOT Call for TAP Grant Applications.** GDOT recently released a FY 2022 Call for Projects for the Transportation Alternatives Program (TAP). TAP projects are for pedestrian facilities, bicycle facilities, and pedestrian streetscaping projects. HAMPO is not an eligible project sponsor, and the Local Public Agency undertaking the project must be Local Administered Project (LAP) certified by GDOT. The City of Hinesville is the only LAP-certified agency in the MPO region. The project must have a 20% local match, and the minimum project cost is \$1,000,000.

Ryan Arnold, Assistant City Manager for the City of Hinesville gave an overview of the training to be certified.

Joey Brown, Liberty County Administrator stated that the County is in the process of re-certification.

E.G. Miles Pkwy Special PL Study Update. This study was successfully awarded by the Special PL committee at the Spring 2021 GAMPO meeting. The RFP draft is under development and will be published upon receipt of the funding contract from GDOT. The anticipated timeline tentatively calls for the publication of the RFP in late June 2021, selection announcements in August, and contracting and negotiations in fall 2021. Anticipating less than a year for completion of the study project. We received \$200,000 Total (80% Federal funding, 20% Local funding.) The 20% portion will be covered by T-SPLOST funding. Rachel stated that she received notification this week that a PI number has been issued for this project. Awaiting contract from GDOT.

Administrative Modification FY 2022 UPWP. On June 1, 2021, GDOT Office of Planning requested an administrative modification be made to the FY 2022 UPWP. This administrative modification revises the funding total of the Freight Planning task under the System Planning element for the FY 2022 UPWP budget summary table. The document has been posted to the MPO website.

HAMPO Certification Review. MPOs are certified every four years to ensure that they are carrying out the metropolitan planning process in adherence with federal statutes and regulations. HAMPO's last self-certification review was in 2016. GDOT and HAMPO staff held a kick-off meeting on April 20, 2021, to initiate the self-certification process. The preparation of certification report is underway.

Kenny Howard asked Rachel to get in touch with DeLisa Clift of the M/WBE. Tom Caiafa stated that they are aiming to have the virtual visit in July. **GAMPO Special PL Funding Application.** This is the call for future potential projects. The next round for Special PL funding applications is due in September 2021. This will need to be on the next TCC and CAC agenda for recommendation at the next PC meeting. Please send recommendations to Jeff Ricketson. Tom Caiafa with GDOT gave the overview of the timeline for submittals.

4) **NEW BUSINESS:**

a. Agency and CORE MPO Updates: Tom Caiafa with GDOT and Mark Wilkes with CORE MPO gave an update.

5) **OTHER BUSINESS:**

a. Chairman Lovette asked for an update on the Highway 84 median project. Troy Pittman with GDOT stated that the PE funds have been authorized and they are waiting on initial schedule to be developed.

6) **PUBLIC COMMENTS:**

• Phil Odom, CAC Chairman stated that there are vacancies on the CAC and would like for the committee to recommend someone for There were no public comments presented at the meeting.

7) **SCHEDULE:**

• Phil Odom made a motion to adjourn. Tom Caiafa seconded the motion and the motion passed unanimously.



Trips per Revenue Service Hours for All Routes August 2019 - July 2020 August 2020 - July 2021










Trips per Revenue Service Hours for Route 1 August 2019 - July 2020


