- System Highlights:
 - Liberty Transit is continuing to meet with partners regarding TDP implementation

Fixed-route ridership increased 19% year-over-year in July (1,641 to 1,951)



Paratransit ridership increased 47% from July 2024 – July 2025 (669 to 981)
